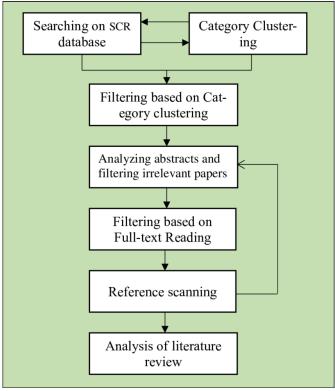


Figure 1. Flow Chart Literature Study
